## Honours & Awards Criteria

The roles and responsibilities of branch Presidents, Treasurers and Secretaries are clearly laid out in the member's handbook, as are the criteria and purpose for the Dearnley and Telemachus Medals.

Our branch specific honours and awards each have their own criteria. They are:

### Life Membership:

- Has maintained at least 10 years unbroken financial membership of Ulysses Club and Mornington Wanderer's;
- Has made a *significant* contribution to the Mornington Wanderer's over that time;
- Has been nominated and seconded by current & financial members of Ulysses Club and Mornington Wanderer's;
- Nomination received by the Branch Secretary, no later than 31 December, and must contain full details in support of the nomination;
- If the Branch Committee will consider all nomination(s) for Life Membership at the January committee meeting, and determine which, if any, are accepted;
- The Branch Committee is not obligated to accept any nominations;
- Only one Life Membership can be awarded in each calendar year;
- Unsuccessful nominations will be advised by the Branch Committee as soon as possible after the decision has been made;
- Nominees and seconders are not required to advise the nominee or obtain his/her approval prior to the nomination, however they are not prohibited from doing so if deemed appropriate;
- the award will be presented by the current President at the next following AGM, immediately following the outgoing committee members final reports (and prior to declaring all committee positions vacant); and
- The Branch will then assume responsibility for ongoing payment of the branch Life Member's social contributions.

### Biggles Presidential Award:

Graham (Biggles) King was the founding President of the Mornington Wanderer's Branch in 2001. He served two terms as President, each time for two years. Apart from his work on the committee, Graham has become a central character within the Mornington Wanderer's Branch. This award bears his name for his enduring commitment and service to the Mornington Wanderer's Branch. The award is presented to:

- The branch member who makes the most significant contribution to the branch over the preceding year;
- The recipient is determined by the President, with such assistance as he deems necessary;
- The award is presented by the President or his nominee at the annual Christmas function.

### Community Service Award:

- Awarded to the branch member for significant and sustained contributions to the general community,
- The contributions need not be related, directly or otherwise to the Ulysses Club or the Mornington Wanderer's Branch;
- Seconded nominations together with written supporting evidence are to be presented to the branch committee for consideration;
- Upon consideration, the branch committee must accept or decline the nomination and advise the nominating member(s) as soon as possible.
- The award is to be presented by the President or his nominee at any branch social or General Meeting.

### Dave Robinson Award:

Dave (The Reverend) Robinson was a founding member of the Mornington Wanderer's Branch. Whilst never serving on the committee, Dave was always actively involved in the branch affairs, rides and social events. Dave was a respected figure of the Mornington Wanderer's, hence the annual branch riding award is named in his honour. This award is presented to:

- The branch member who accrues the highest points tally for Ride Leads, Tail End Charlies and attendances in a single calendar year (normally calculated between annual Christmas functions);
- Shared Ride Leads or Tail End Charlie duties will each attract maximum points;
- A member need not complete the ride to be awarded the point(s) for it.
- The award is presented by the President or his nominee at the annual Christmas function.

### Robert (Slim) Sangster Participation Award

Robert (Slim) Sangster was a Branch Member who again never actually served on the Committee, but was always up for a Social Function, Weekend Away no matter what the weather. This award is presented to:

- The branch member that participates in the most Branch Functions over the course of the year and accrues the highest points tally for attendances, Salads and hosts in a single calendar year (normally calculated between annual Christmas functions);
- Joint hosting duties will each attract maximum points;
- The award is presented by the President or his nominee at the annual Christmas function.



## **Rookie of the Year Award**

This award will be presented to the Mornington Wanderers member who has shown true Ulysses Club spirit, whilst:

- holding a motorcycle licence for not more than two years, and
- participated in a minimum of 6 rides, as a rider, in the period between December and November the following year. (between annual Christmas functions).

Nominations will be discussed by the Committee and the winner decided by majority vote.

The award will be presented by the current President, or his nominee at the Christmas Function in December each year. The award need not be presented if no suitable nominations are received.
